

Product description

Synthetic microfibers belonging to the additives range to be used in addition to RESIN 3+, to obtain compounds with different characteristics. They have an average length of 500 microns and, when mixed with RESIN 3+, they reinforce its structure by creating a multidirectional network within the compound; at the same time, since they have low absorption, they do not alter the penetration characteristics of the RESIN 3+ into the substrate. They can be used for "fillet" type structural bonding (for bonding "T" joints) where a high density and strong structure structural filler is required.

Application and use

APPLICATION PROCEDURE

Add the additive to RESINA 3+ only after carefully mixing component A and component B in a 2:1 ratio.

<u>Fluid glue</u>: Mix 2 parts of catalyzed RESINA 3+ + 1 part of R-Fibers to obtain a fluid glue suitable for gluing surfaces with small imperfections.

<u>Structural bonding:</u> Mix 1 part of catalyzed RESINA 3+ + 1 part of R-Fibers to obtain a light structural compound suitable for bonding surfaces with large imperfections.

<u>High-density structural bonding</u>: Mix 1 part of catalyzed Resin 3+ + 2 parts of R-Fibers to obtain a high-density structural compound capable of remaining in position even in vertical applications.

Storage

It is recommended to avoid exposure to air and extreme temperatures. To maximize the shelf life in the can, it is good to check that the container is well closed during the storage and the temperature is between 10 °C and 35 °C. Avoid exposure to direct sunlight.

Safety rules

Operate in well ventilated places and, if in closed areas, use vacuum cleaners, fans and air conveyors. During the application, use appropriate protections (masks, gloves, glasses, etc.).
